
It was close scoring until the end of the event. SCS with 29 points, LO with 25 and Lansing with 18.

2023 Fall Meeting of Passed and Failed Bylaw Change Proposals

Article II - Section 7 - Currently Reads:

Section 7. The Constitution and By-laws, Rules and Regulations may be revised by submitting changes at any membership meeting or sent to the chairperson of the Constitution and By-laws Committee by July 15. Such proposed revisions shall be published in the MHPA's August newsletter. All proposed revisions shall be voted upon at the State Tournament meeting. Any additions, deletions and/or changes shall be approved by a two-thirds vote of members present at the meeting and shall become effective January 1 of the following year. The president may at his/her option, have the State Tournament meeting later if tournament scheduling or other unforeseen reason does not allow proper time for the meeting to be held during the tournament.

Proposed Change:

The Constitution and By-laws, Rules and Regulations may be revised by submitting changes at any membership meeting or sent to the chairperson of the Constitution and By-laws Committee. All proposed revisions shall be voted upon at the either of the annual membership meetings. The spring meeting or the fall meeting during the State Tournament. The deadline for submitting for the spring meeting will be March 15. The proposed revisions shall be published in the April newsletter (Spring Meeting) and the August newsletter (State Tournament) meeting. Any additions, deletions and/or changes shall be approved by a two-thirds vote of members present at the Spring or State Tournament meeting. (Each individually, attendance at one meeting does not constitute attendance nor a vote at the other). Those approved at the Spring Meeting shall become effective the first of the month following the Spring Meeting. Those approved at the State tournament meeting shall become effective January 1 of the following year. The president may at his/her option, have the State Tournament meeting later if tournament scheduling or other unforeseen reason does not allow proper time for the meeting to be held during the tournament.

Reasoning for Change:

The deadline for submitting for the State Tournament meeting July 15. Help encourage the MHPA membership to attend the spring meeting while at the same time encouraging their voices to be heard. The additional vote would also allow the MHPA to be more flexible to member concerns or changes to keep the quality of the game and experience at the highest possible level. Especially when it comes to state tournament issues.

Proposed by Josh Lull FAILED

Article VII - State Tournament Section 7 – Currently Reads

Section 7. Any club that meets the requirement of 18 lighted courts should be able to host the singles state tournament. Voting will take place during the meeting at the state tournament. If there is no host club for the singles state tournament, the executive council will then contact qualified clubs and award one of them the tournament. Only the MHPA will be allowed to do 50/50 raffles during the State Tournament to supplement the prize money.

Proposed Change:

Any club that meets the requirement of 18 lighted courts should be able to host the singles state tournament. (Remove the portion in regard to voting taking place during the meeting.) The executive council will contact qualified clubs and award one of them the tournament. The MHPA will decide how 50/50 raffles are conducted and by who during the State Tournament to supplement the prize money.

Reasoning for Change:

The MHPA is currently not in a position where voting is necessary to decide who hosts the state singles tournament. Let's hope in the future the MHPA is able to get back to where that is a valid concern. At that time a re-instating a vote would be completely valid to make sure not favoritism is shown, and the joy of the tournament is shared. Currently the MHPA only has a couple of locations. In regard to the 50/50 raffle this allows the MHPA to be more flexible in possibly trading the conducting and proceeds of the raffle for possibly a more lucrative benefit in increasing the prize payouts at the State Tournament.



Section 8 – Currently Reads

This association shall award the Junior Boy and Junior Girl State Champion a \$100 scholarship each. These scholarship monies shall be awarded upon a college, university or trade school's letter of enrollment to the association. This award must be claimed before their twenty first birthday. Junior and Cadet players are to pay the State Tournament entry fee. They will be eligible to receive monetary awards for the class pitched in.

Proposed Change: Addition of a sub-section. An exception to Section 8.

A. In the event that either the Junior Boy or Girl are the only one in their class at the state tournament, they are given an option to be classed in a 30' group thus relinquishing eligibility to be the junior boy or girl champion for that year. However, they are eligible for the plaques and monetary awards in that 30' group. This option is only given when either that Junior Boy or Girl are the only participant in their class in the state tournament. If the Junior Boy or Girl declines the option of pitching in a 30' group, they will be awarded the scholarship. (Tournament entry fee refunded) However, they are then only allowed to pitch as a pacer in another group/class. Not eligible for awards and or plaques.

Reason for Change:

This gives the MHPA and the junior pitcher some flexibility when it comes to an issue that has been a struggle for some time. We want to provide competition but also conduct it in a way that is consistent with the rest of our groups\classes. With the very unstable participation at the junior levels this flexibility would allow the MHPA to provide a competitive experience with award eligibility if the junior pitcher chooses to do so. I believe it is also important to keep in consideration that we need to keep these juniors at 30' and also recognize we would be in a bit of dicey situation in regards to of Rule 1 Pitching Divisions Section A subsection 2,3 of the RGS. Our use of the mix classes is where I believe we can allow them to play without relinquishing their junior status.

FAILED

Article VIII - State Doubles Tournament: Section 10 - Currently Reads

The cost of the cookout/potluck meat will be paid for by the MHPA. Proposed Change: Remove section 10 completely.

Reasoning for Change:

The MHPA is currently not in a position to allow for a blank check purchase of a "meat" dish for either of its two state tournaments. This is not a consideration nor a rule for the State Singles Tournament. Why the State doubles? Treat the State doubles tournament just like the State singles tournament. The cost liability must be taken on by the host club. The financial position of the MHPA improves enough to consider handling the cost of the meals at our State Championships this topic could be revisted as a policy. *Proposed by Josh Lull*



Article VI: Tournaments - Section 11 – Currently Reads

All MHPA sanctioned tournaments shall be 35 point cancellation. Any game at a state singles tournament between two pitchers with a 25% or lower ringer percentage shall play to 30 points or 60 shoes, whichever occurs first. Any game at a district tournament between two pitchers with a 25% or lower ringer percentage shall play to 35 points or 50 shoes, whichever occurs first. In case of a tie game the pitchers shall pitch down and back (four shoes) until a winner is decided. If a class consists of only 5 players at a district tournament, they will be allowed to pitch to 40 points. The 25% rule would remain the same.

Proposed Change:

All MHPA sanctioned tournaments shall be 35 point cancellation. Any game at a state singles tournament between two pitchers with a 25% or lower ringer percentage shall play to 25 points or 50 shoes, whichever occurs first. Any game at a district tournament between two pitchers with a 25% or lower ringer percentage shall play to 25 points or 50 shoes, whichever occurs first. In case of a tie game the pitchers shall pitch down and back (four shoes) until a winner is decided. If a class consists of only 5 players at a district tournament, they will be allowed to pitch to 40 points. The 25% rule would remain the same.

Reasoning for Change:

It seems that one area we see lack of scorekeeping is when it comes to classes were the pitchers are predominantly under 25%. Games are longer (If they get closer to the shoe limit and less exciting due to lack of dead ringers and lower scores) 25 points is an amount that is quite achievable by most pitchers under 25%. Games feel exciting because there is a good chance either participant is going to reach that amount and simply outlast the other by hitting the shoe limit. In my opinion the move to 30 pts was in the right direction but the at the same time moving to a 60-shoe limit was a bad idea. Both decisions together cancelled each other. Now one could argue the MHPA has plenty of games with pitchers both over 25% that go over 50 shoes. Well Yes, we do. However, that usually means both pitchers are pitching well and the game includes a fair number of live and dead ringers for a competitive game. With the higher competition when one pitcher is not pitching well that game will most likely be quite short. (In terms of time and innings) A good chance with pitchers under 25% if one is not pitching well the other does not pitch well enough to shorten that game. (In terms of time and innings) Really an idea to help shorten our time a bit and make the game more exciting for all.

Proposed by Josh Lull

WAS VERY SIMILAR TO A PROPOSAL BY DEAN SCHMITZ FOR THE SAME RULE. THOSE IN ATTENDANCE LIKED

DEAN'S BETTER. WE DECIDED TO DISREGARD THIS ONE IN FAVOR OF VOTING FOR THAT ONE. NO VOTE.

Article VII: State Tournament Section 4.

"While pitching, all participants of the State Singles Tournament shall wear a shirt or blouse with their last name professionally lettered on the back."

Proposed Change: Add to the Article VII: State Tournament Section 4 of the MHPA Bylaws to include "sleeveless shirts **allowed** excluding cutoffs, and spaghetti strap tank tops."

Reason: Currently the MHPA bylaws does not specifically state "no sleeveless shirts" allowed, only the NHPA rules identify no sleeveless shirts for the world tournament and **may** also be **adopted** into any Charter Bylaws or **may be** enforced at any State Championship Tournament or at any local tournament, **if announced in advance by the Tournament/League Officials.** Contestants who do not comply may not be allowed to participate in the event".

Proposed by Brandy Morehead



Section 11.

All MHPA sanctioned tournaments shall be 35 point cancellation. Any game at a state singles tournament between two pitchers with a 25% or lower ringer percentage shall play to 30 points or 60 shoes, whichever occurs first. Any game at a district tournament between two pitchers with a 25% or lower ringer percentage shall play to 35 points or 50 shoes, whichever occurs first. In case of a tie game the pitchers shall pitch down and back (four shoes) until a winner is decided. If a class consists of only 5 players at a district tournament, they will be allowed to pitch to 40 points. The 25% rule would remain the same.

Proposed change: Change to 40 shoes

Reason: Because it takes way too much time for pitchers in these classes. *Proposed by Dean Schmitz*

PASSED

Section 9.

Any MHPA club that meets the requirements of having 12 similar courts may be able to host the Doubles State Tournament. Bids will be accepted at the fall scheduling meeting. If more than one club bids, Tournament Directors present will vote to award the club. The club must be able to host a cookout/potluck meal in between the morning and afternoon sessions.

Proposed: Remove The host club must add \$200.00 to the prize money. Only the host club will be able to run 50/50 drawings during the tournament.

Reason: This sentence should be dropped because the host club is doing enough by hosting the doubles tournament.

Proposed by Dean Schmitz

PASSED

Section 10.

A new member or a member who does not have an established ringer percentage shall pitch 100 qualifying shoes that must be witnessed by 2 NHPA members or use a NHPA sanctioned league ringer percentage based on four hundred (400) or more shoes.

Reason: The NHPA changed this a few years ago to 200 shoes. *Proposed by Dean Schmitz*

Appendix A: Miscellaneous Rules

A. Copies of rules, regulations and the Constitution and By Laws shall be given to all new members and published in the newsletter each year for current members.

B. Jean Swarthout, Dick Frakes, Paul "Dewey" Howard, Bob Wells and Paul Wishon are granted lifetime membership to the MHPA. (Lee Jacobs will forever remain on the active membership rolls.)

Proposed Change: Remove Jean Swarthout and Paul Wishon from Bylaw and add Judy Curtiss

Reason: Jean and Paul are deceased. I believe Judy Curtiss is on this list. It should be updated.



Reason: There are a number of pitchers who do not like walking doubles. Most of our pitchers have pitched in bar leagues or doubles recreation leagues with all pitching non-walking doubles. They are used to throwing their partners shoes. This should be an added interest to the schedule.In regular doubles, both team members use the same pair of shoes, and all contestants stay at the same end of the court for the entire game. To begin the game, the highest-rated contestants will decide on the first pitch and deliver their shoes, just as in singles competition. Count-all scoring. No handicap.

NO NEED, AS THE NHPA ALREADY ALLOWS FOR THESE TYPES OF TOURNAMENTS.

The combined NatStats average of both players must not exceed 120.
